TERMS & CONDITIONS FOR PACKED MILK TRANSPORT

1. (A) DELIVERY OF THE MILK:

The transport contractor shall make an arrangement for delivery of packed milk, milk products and dairy material in cartons/containers/bottles/crates from the Mahanand Dairy unit Plot No. 959/60/61 post-Hingangaon, (BK) Taluka-Kadegaon, District-Sangali and or packed milk vehicle crossing stations in sindhudurg district, to the selling points of Agents/Distributors/Retailers & Railway Milk Parlors etc. Details of locations/destinations will be provided separately, MRSDMM whenever required will make changes in it. The delivery of the products shall be made as per the schedule given to transport contractor. The loading and unloading of the milk, milk products and dairy material shall be the responsibility of the transport contractor at his own cost..

(B) The transporter will be responsible for loading the milk & milk products stock from the Hingangaon, sangli dairy plant & substation Talere /Banda , sindhudurg and deliver it to all points as per daily schedule. The Delivery of milk, milk products and dairy material shall be made at the shop /point of distributors and parlors (and not on Road) stall on the railway platforms or railway premises.

(C) The transport Shall at his cost deploy his own employees (minimum two loaders for loading & unloading of goods) for delivery of milk & milk product & receiving the acknowledgement of delivery & submit all acknowledgement daily at the dairy .transporter shall arrange double vehicle with double driver & also double loader for Main Panjimroute .

(D) The transporter should deploy (appoint) two loaders for loading and unloading of packed milk & milk product . In addition to it also perform all the duties relating to the Loading and Unloading of milk, milk products and dairy material and collection of Cheque/DD/cash. Also he has to Prepare the route delivery statements and also distribute the circulars etc. and reports should be submitted to Mahanand Unit daily .

(E) The transporter shall also perform all the duties such as of returning crates damaged Products & will have to deposit it in dairy within time and in good condition also. In case of spoilage of products in transit the transporter shall be held responsible for which the losses will be recovered from security deposit or any other legal methods.

2. REPORTING TIME:

The transport contractor shall bring the vehicle least two hours before as per schedule given to him from MRSDMM.its dispatch time or such suitable time as may be decided by the Mahasangh for loading milk, milk products and dairy material at the Dairy premises & will leave the Dairy OR from crossing point for Delivery as decided. In case of delay in departure he will be penalized as per the penalty clause.

3. COLLECTION OF CONTAINERS & CRATES:

The transport contractor shall collect the unsold/empty crates/containers collected from the Agents/Distributors/Retailers & Railway Milk Parlors of the Mahasangh and return them to the Dairy in good condition every day.

4.CONDITION OF THE TRANSPORT VEHICLE:

The transport vehicle shall be insulated and it shall be very clean from hygienic point of view.if a/c required for insulated vehicle .transport contractor shall make that arrangement as per MRSDMM suggestion. The provision of good light should be made in the carriage compartment of the vehicle to facilitate checking/counting of packed milk& milk products. In case of break-down the transport contract shall arrange an alternate arrangement by providing the vehicle for transporting the milk, milk products and dairy material. In no case, the distribution of milk products should be delayed to the Agents/Distributors/Retailers & Railway Milk Parlors.in the event of failure to do so MRSDMM Shall make arrangement at the cost of transport contractor, such cost shall be recovered from the security deposit,and or by other legal modes.delay charges shall at the @Rs.200 per delayed hour.this shall be without prejudice to other remedies provided here in or under relevant acts.

5.TRANSIT LOSSES:

The transport contractor shall check the milk products along with pouches of milk /milk product before its acceptance for delivery as per schedule given. The cartons, containers, crates, bottles of milk products broken/damaged or lost during the transit will be the responsibility of the transport contractor and the full amount of the damages, if any will be recovered from the transport contractor in cash or from his bills.and or from security deposit and or by any other legal modes.

6. SECURITY DEPOSIT:

The transport contractor shall deposit the security deposit of Rs.50000/-for per vehicle vehicle in the form of D.D. immediately on signing of the agreement. The payment of security deposit shall be the condition precedent for operating the route for distribution

of milk products. The deposit so paid shall not bear any interest. The amount of security deposit will be refunded to the transport contractor only after successful completion of his agreement & only after setting accounts pertaining transaction arising out of his agreement .MRSDMM Shall be liberty to deduct from security deposit all amounts which might have become due and payable by the transport contractor to MRSDMM.

7. DETAILS OF VEHICLES AND ITS UPDATION:

The transport contractor before plying the vehicle should given the following Information:-

- (a) Vehicle Registration No.**
- (b) Year of Manufacture**
- (c) Capacity of the vehicle**
- (d) Name of the Driver (along with Passport size photography) and his License No. & Address**
- (e) Insurance Policy No. date and validity period.**

The entire responsibility to fulfill the statutory requirement and liabilities in respect of vehicle and persons engaged by the contractor shall rest with the contractor.

8. FAILURE TO LIFT THE MILK & MILK PRODUCTS:

- a.) In case the transport contractor fails neglects or avoids lifting the quantity of milk products as per the schedule given to him, the Mahasangh shall impose the penalty of Rs. 2000/- per day/vehicle on its own discretion. In addition, the cost incurred for deploying alternative vehicle, the entire cost/freight brought will be recovered from the Transporter.
- b.) In case due to unavoidable circumstances the transporter deploys non insulated vehicle then that day the transporter will be given non insulated vehicle charges penalty will be levied @ Rs.500 /Day.
- c.) In case, if the transporter purposely deploys non-insulated vehicle without any permission then the transporter will be penalized as well as any loss to product/Mahasangh will be recovered by the contractor.

9. NON – TRANSFERABILITY:

This transport contractor shall not be sublet, transfer or assigned to any third party .however with prior written permission of MRSDMM .transport contract may be assigned to the legal heirs in which case prior written permission of the Mahasangh should be obtained.

10. OBSERVANCE OF RULES, REGULATIONS & CIRCULARS ETC.

- a) The Rules and Regulations framed by the Mahasangh and the instructions, circulars and notifications etc. issued by the Mahasangh from time to time as to the working. Management and discipline shall be binding on the transport contractor and he/they shall observe and follow them strictly.

- b) It is initial responsibility of contractor to take the insurance policy of average max.value of milk& cratesor Milk product for one day& submit same copy to Mahanandunit for security purpose .

11. STACKING OF CARTONS, CONTAINERS & CRATES:

The transport contractor shall not stack the crates more than 10 crates per stack and 5 cartons per stack in the vehicle. The carriage should have removable arrangement to load Crates / Cans / Cartoons. Its contractors responsibility ofLoading & unloading of crates from edge of dairy dock to distributor point given by Mahanand.

12. PAYMENT OF FREIGHT:

The transport contractor shall raise the bills for duration of every completed period of fifteen day or one months and the bill raised will be processed for payment after taking into consideration the losses, shortages, damages etc. occurred to the milk /Milk products during the transport and provided he meets the statutory requirements of PF &ESIS contributions in respect of the employees (driver etc.) he has recruited for plying vehicles.

12 (a) MRSDMM shall deduct TDS & other statutory deductions from the bills as per the provisions of relevant laws

12 (b) The transport contractor should have Provident Fund Account in respect of his Employees and shall produce the PF Account No. to DudhMahasangh and shall follow relevant rules.

12(c) The transport contractor should have ESIS Account Number in respect of his employees

12(d) For any liability in respect of income tax, PF, ESIS arising out of contract shall be the sole responsibility of transport contractor even after expiry of contract. It is whole responsibility of transport contractor only to pay stamp duty charges.

13. STATUTORY INCREASE/DECREASE IN FUEL CHARGES

During the Period of contract if Govt. or petroleum companies revises the rates of fuel ,the same may be taken into account while revising the rate from the date of its revision such revision may be plus or minus and will be effected from the next billing month .

14. DISCIPLINE:

The transport contractor and/or his employees or/any authorized representative shall follow proper discipline in the Dairy premises and with the Agents/Distributors/Retailers of MRSDMM and co-operate with the staff of Mahasangh/Dairy. The transport contractor shall not enter into the prohibited area or the laboratory of the Mahasangh without the permission in writing from Mahasangh/Dairy and shall be responsible for any loss, damage, brokerage, theft or pilferage of milk, milk products and property that is caused

by them to the Mahasangh/Dairy. The transport contractor is liable to pay to the Mahasangh the amount of loss or damage or shortages caused to the property as may be decided by the Mahasangh. The transport contractor shall not appoint any other person(s) as his representative for the dealings with the Mahasangh without obtaining the specific permission of the Mahasangh/Dairy in writing.

The transport contractor shall not delegate any of his duties and responsibilities which might result in the termination contract as per the terms and conditions of the contract and/or other disciplinary action against the transport contractor.

15. TERMINATION OF CONTRACT:

The Mahasangh is entitled to discontinue the transport contract and/or terminate the agreement and forfeit the security deposit without any notice to the transport contractor on any changes in Managements policy decision or any of the following grounds:

- (a) After delivery of milk /milk product to transport contractor If any composition, quality or quantity of milk pouch or milk product is found to be adulterated ,altered or different from what is supplied by the Mahasangh/Dairy for the delivery
- (b) If the transport contractor fails to pay the delay charges or compensate losses /damages as per the clauses of the terms and conditions of the contract.
- (c) If the transport contractor or any of his employees are found to have caused any loss, theft or pilferage etc. of milk, milk products and dairy material or damage to any property of the Mahasangh/Dairy.
- (d) In case of any misbehavior or misconduct or any breach of the rules and regulations or instructions, circulars or notifications of the Mahasangh/Dairy on the part of the transport contractor, or his authorized employee or representative with the staff of Mahasangh/Dairy.
- (e) If in the opinion of the Mahasangh, the transport contractor or his employee, commits any act or deed, injurious to the credit or reputation of the Mahasangh/Dairy or does any act or deed to lower down the prestige of the Mahasangh/Dairy in the eyes of the public or works against the interest of the Mahasangh/Dairy or acts in any of the way in a disgraceful manner or indiscipline manner or causes any harm to the funds and property of the Mahasangh/Dairy.
- (f) If the transport contractor fails to arrange the alternate vehicle to deliver the milk products as per the delivery instructions and/or as per the scheduled time given to him. In case of such failure on any account, the contractor shall have no right/claim against the Mahasangh.

- (16) PERIOD OF CONTRACT** This transport contract shall commence from the date of its execution for three years (01/06/2022 to 31/05/2025) till the same is terminated under Clause of this terms and conditions of the contract, whichever is earlier. The Mahasangh

reserves the right to extend the contract period for further period of six months at the same rate and on same terms and conditions.

(17) TERMINATION OF AGREEMENT: This Agreement may terminate at any time during the duration of this contract period mentioned in Clause-15 be terminated by giving One month notice by the Mahasangh or the transport contractor in that behalf to the other.

(18) DISPUTES: Any disputes arising out of this contract for example, transport of milk products, management and business, payment of dues etc. shall be referred to the Managing Director MRSDMM, in the first instance and his decision will be final and binding. The aggrieved party may refer the disputes for trial and adjudication to the Co-operative Court on certification by the Registering Authority. Further, the adjudication for all intends and purposes shall be "P" Ward, Greater Mumbai or as may be noticed by the Registering Authority or the Government

(19) NOTE FOR INSULATED VEHICLE SPECIFICATION:

Vehicle should be fully insulated means all sides of vehicles should have at least Two inch thermacol coating and bottom part should have wood plank or ply which is water proof and fire proof.if a/c required for insulated vehicle . transport contractor shall make that arrangement of extra A/C cooling system should be for vehicle.
