GENERAL TERMS AND CONDITIONS AND IMPORTANT INSTRUCTIONS FOR THE PURCHASE OF SKIM MILK POWDER AND DESI COOKING BUTTER FROM MAHANAND SMP PLANT VARVAND.

1. e-tender can be downloaded in the form prescribed by the The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy), Goregaon (East) Mumbai – 400065. For the sale of SKIM MILK POWDER AND DESI COOKING BUTTER upto the date and time mentioned on the tender notice.
2. Tenderer should quote rates for SKIM MILK POWDER AND DESI COOKING BUTTER exclusive of taxes and duties Ex-MAHANAND VARVAND SKIM MILK POWDER AND DESI COOKING BUTTER PLANT, AT POST-VARVAND, TAL- DOUND, PUNE-SOLAPUR HIGHWAY, DIST.: PUNE -412215 and submit the quotation using e-tendering system.

(A) **TECHNICAL (Compulsory documents) :**

- 1) Screenshot showing online payment made toward Tender fee & EMD.
- 2) Declaration letter stating that all tender terms and conditions for the purchases stipulated by the Department are acceptable to the firm. (Pl. attached terms and conditions acceptance letter)

(B) **COMMERCIAL DOCUMENTS :**

"PRICE TENDER FORM (purchased for himself and encrypted by digital certificate) showing rates (exclusive of Taxes and Duties) Ex-Mahanand Varvand SKIM MILK POWDER AND DESI COOKING BUTTER Plant, At post- Varvand, Tal-Dound, Pune-Solapur Highway, Dist. Pune."

3. The tenderer shall quote the rate of offer in BOQ (Excel Sheet) only in figure and full words. The rate offered shall be as per the conditions in the tender.
4. The Tenderer shall have to make his own arrangements for transport and labour to lift the SKIM MILK POWDER AND DESI COOKING BUTTER under disposal purchased by him from the place of storage in the deep freeze within stipulated period prescribed in Acceptance of Tender/Order. The time limit for lifting the stocks offered will be only 10 days OR as decided by The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) after accepting the offer by paying entire cost of SKIM MILK POWDER AND DESI COOKING BUTTER along with all taxes applicable.
5. While allotting the stocks to the successful Tenderer as far as possible the preferences given will be considered as per the availability of stock and need to dispose it off and it will be binding on him to lift the entire allotted stock. If the Tenderer fails to lift the SKIM MILK POWDER AND DESI COOKING BUTTER under disposal or any part thereof, The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) at his option is entitled either to recover from EMD.
6. If the successful Tenderer fails to lift the SKIM MILK POWDER AND DESI COOKING BUTTER under disposal offered to him within the scheduled time he will be charged the storage charges for the space occupied by the SKIM MILK POWDER AND DESI COOKING BUTTER and in such cases, the decision taken by The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) shall be conclusive and final. The penalty on such account shall be recovered from the EMD.

7. In the event of the failure of the successful Tenderer to pay the cost of the SKIM MILK POWDER AND DESI COOKING BUTTER within the time limit, the amount deposited with The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) as Earnest Money Deposit is liable to be forfeited to the Mahanand Dairy and the Acceptance of Tender placed with him is liable to be cancelled.
8. **Opening of Tender:** The Tenderers are at liberty to be present or authorize their representative in writing to remain present for opening of technical tender envelope as well as Commercial envelope at the time and date specified on the tender form.
9. In case of Tenderers whose offers are not accepted, their Earnest Money Deposit will be refunded in due course. In case of successful Tenderer, the Earnest Money Deposit amount deposited with The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) will be retained the EMD and will be returned only without any interest after completion of lifting SKIM MILK POWDER AND DESI COOKING BUTTER offered to him in Acceptance of Tender/Order from respective places.
10. The successful Tenderer shall have to abide by the instructions given by The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy).
11. In case of disputes with regard to any of the terms and condition of the Tenderer and there fulfillments or otherwise the decision of The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) shall be final and binding on the Tenderer.

The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) reserves the right to accept or to reject the highest or any other tender without assigning any reason therefore and also to allot the SKIM MILK POWDER AND DESI COOKING BUTTER to more than one Tenderer at a time, at his discretion.

HDFC0000145.** Gate pass for removal of the SKIM MILK POWDER AND DESI COOKING BUTTER will be issued by the Incharge Mahanand SMP Plant Varvand. The successful Tenderer should see that the dairy routine working is not hampered by any means while removing, loading and transporting the SKIM MILK POWDER AND DESI COOKING BUTTER from the dairy premises.

16. The Tenderer may inspect the SKIM MILK POWDER AND DESI COOKING BUTTER before opening of the tender and quote the rate. The losses and damages arising out of accident, fire etc. to the SKIM MILK POWDER AND DESI COOKING BUTTER under disposal, other Dudh Mahasangh machinery / equipment, Mahasangh building or part of the building during the execution of the contract, shall be recovered from the Tenderer and shall be at the discretionary power of The Managing Director, Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit Mumbai (Mahanand Dairy) and the same will be binding on the successful Tenderer.
