- 1) Maharashtra Rajya Sahakari Dudh Mahasangh Maryadit (MRSDMM) requires 2 vehicles at present. Tenderer may have to supply additional vehicles on the same terms and conditions and rates also.
- 2) Transporter should provide fully insulated vehicals,which should not be more than 8 years old.
- 3) Vehicles should be made available at the Goregaon dairy at 11.00 P.M. and after loading the vehicle it should leave dairy premises by 4.00 A.M., (or as per the instructions given by MRSDMM from time to time).
- 4) Loading & unloading of the Milk Pouch (as per requirement), Tetra Milk, Milk products & Dairy's Other Material in the vehicle has to be done by transporter at his own cost.
- 5) Product for dispatch will be made available from MRSDMM Dairy at Goregaon, Mumbai.

TERMS & CONDITIONS OF MILK PRODUCT TRANSPORT

1. DELIVERY OF THE MILK & MILK PRODUCTS:

- (a) The transport contractor shall make an arrangement for delivery of milk & milk products in cartons/containers/bottles/crates from the Mahanand Dairy situated Goregaon, Mumbai , out of Mumbai & Goa to the selling points of Agents/Distributors/Retailers & Railway Milk Parlors. Details of locations/destinations are mentioned herein and may also be provided separately. MRSDMM whenever required will make changes in it. The delivery of the products shall be made as per the schedule given to transport contractor. The loading and unloading of the products shall be the responsibility of the transport contractor, at his own cost.
- (b) Transporter should provide fully insulated vehicles, which should not be more than 8 years old.
- (c) The transporter will be responsible for loading the milk products from the Goregaon dairy and deliver it at the locations as per schedule given by the MRSDMM from time to time. The delivery of products shall be made at the shop /godown of distributor, (and not on road).
- (d) The transporter shall at his cost deploy his own employees for delivery of all stocks/ Milk Pouch, Tetra Milk, Milk products & Dairy's Other Material and receiving the acknowledgement of delivery, and submit all acknowledgements daily or next day at the Goregaon dairy.
- (e) The transporter shall also be responsible for returning damaged, undelivered returned products & will have to deposit it in dairy within time at the earliest and without further spoiling, in case of spoilage of products in transit the transporter shall be held responsible and the losses will be recovered from him, from the security deposit and or by other legal methods.

2. REPORTING TIME:

The transport contractor shall bring the vehicle as per the schedule given to him from time to time by MRSDMM for loading products at the Dairy

premises & will leave the Dairy for delivery before 4 a.m. or as per schedule. He shall have to pay delay charges as provided here in.

3. COLLECTION OF CONTAINERS & CRATES:

The transport contractor shall collect the unsold products/empty crates/containers collected from the Agents/Distributors/Retailers and return it to the Dairy without any deterioration. Empty Crates should be return/submit to the Dairy Section daily or next Day. & crates receipts copy should be submit to distributor. If he failed transporter shall be held responsible and the losses will be recovered from his Monthly Transport bills, from the security deposit and or by other legal methods.

4. CONDITION OF THE TRANSPORT VEHICLE:

The transport vehicle shall be insulated and it shall be very clean and hygienic. The provision of adequate light should be made in the carriage compartment of the vehicle to facilitate checking/counting/ handling of milk products.

Vehicle should be fully insulated means all sides of vehicles should have at least two inch thermacol coating and bottom part should have wooden planks or plywood which is water proof.

In case of break-down of vehicle the transport contractor shall at his cost make an alternate arrangement by providing the alternate vehicle for transporting the milk products. In no case, the distribution of milk products to the Agents/Distributors/Retailers & Railway Milk Parlors should be delayed beyond 2 hrs. In the event of failure to do so, MRSDMM shall make arrangement at the cost of transport contractor, such cost shall be recovered from the security deposit and or by other legal modes. Delay Charges Shall be at the @ Rs.200 per delayed hour. This shall be without prejudice to other remedies provided here in or under relevant acts.

5. TRANSIT LOSSES:

The transport contractor shall check packing of the milk products before its acceptance for delivery. The cartons, containers, crates, bottles of milk products broken/damaged or lost during the transit will be the

responsibility of the transport contractor and the full cost of the damages, if any will be recovered from the transport contractor in cash or from his bills, and or from the security deposit and or by any other legal modes.

6. EARNEST MONEY DEPOSIT (EMD) /SECURITY DEPOSIT:

The E.M.D. shall be forfeited if the successful tenderer fails to accept the contract. Without prejudice to the said action, MRSDMM shall be at liberty to initiate any other appropriate action against the tenderer for breach of contract. The E.M.D. of the unsuccessful tenderer shall be refunded within one month from the date of finalization of the tenders. EMD shall not carry any interest.

The transport contractor shall deposit the security deposit of Rs. 3,20,000/- by demand draft on signing of the contract. The payment of security deposit shall be the condition precedent for operating the route for distribution of milk products. The deposit so paid shall not bear any interest. The amount of security deposit will be refunded to the transport contractor only after successful completion of the agreement / contract by the transport contractor and only after settling accounts pertaining to the transaction arising out of the agreement, .MRSDMM shall be at liberty to deduct from the security deposit all amounts which might have become due and payable by the transport contractor to the MRSDMM, as provided under the terms and conditions of the agreement.

7. DETAILS OF VEHICLES AND ITS UPDATION.

Details of vehicles and its drivers are mentioned in the tender form, as and when there will be any change in it, the transport contractor shall immediately inform it in writing to MRSDMM.

The entire responsibility to fulfill the statutory requirement and liabilities in respect of vehicle and persons engaged by the contractor shall rest with the contractor.

8. FAILURE TO LIFT THE MILK & MILK PRODUCTS:

In case the transport contractor fails, neglects or avoids to lift the quantity of milk & milk products as per the schedule given to him, the MRSDMM will be at liberty to impose inconvenience charges of Rs. 3000/- per day/per vehicle.

In addition, to this the cost incurred for deploying alternative vehicle, shall be recovered from the Transporter, either from security deposit or by other legal modes.

In case, if the transporter deploys non-insulated vehicle without any permission, then the transporter will be liable for quansiquential damages or losses to products and MRSDMM shall recover it from the contractor, which shall be in addition to other legal rights and remedies under law and the Agreement.

9. NON – TRANSFERABILITY:

The transport contractor shall not sublet, transfer or assign to any third party. However with prior written permission of MRSDMM the agreement may be assigned to legal heirs of transport contractor.

10. TENURE OF AGREEMENT :-

Unless there is a breach of terms & conditions of this agreement or the performance of the Transport contractor is un-satisfactory or the Agreement is not terminated for whatsoever reason, this Agreement shall be for a period of 2 year from the date of this Agreement.

11. OBSERVANCE OF RULES, REGULATIONS & CIRCULARS ETC.

The Rules and Regulations framed by the Mahasangh and the instructions, circulars and notifications etc. issued by the Mahasangh from time to time as to the working, and discipline shall be binding on the transport contractor .

12. STACKING OF CARTONS, CONTAINERS & CRATES:

The transport contractor shall not stack the crates more than 10 crates per stack and 5 cartons per stack in the vehicle. The carriage should have removable arrangement to load two storage loading products. (Removable second floor partition for two storage).

13. PAYMENT OF TRANSPORTATION CHARGES ETC:-

The transport contractor shall raise the bills for duration of every completed period of one English calendar months and the bill raised for the will be checked & processed for payment after taking into consideration the losses, shortages, damages etc. occurred during the transportation of Milk & Milk product, compliance, and the statutory requirements such as PF& ESIS contributions in respect of his performance of this agreement.

- (a) MRSDMM shall deduct T.D.S & other statutory deductions from the bills as per the relevant laws
- (b) The transport contractor should have Provident Fund Account in respect of his Employees and shall produce the PF Account No. to MRSDMM and shall follow relevant rules.
- (c) The transport contractor should have ESIS Account Number in respect of his employees.
- (d) For any liability in respect of INCOME TAX, PF, ESIS arising out of the contract shall be the sole responsibility of transport contractor even after expiry of contract.
- (e) In the event of failure of the transport contractor to follow the above mentioned Acts, as result MRSDMM has to pay any moneys to any statutory body, such money shall be recovered from the security deposit or from the bills payable.
- (f) Transport contract should have GST Registration No.

14. STATUTORY INCREASE/DECREASE IN FUEL CHARGES.

That consideration / transport charges agreed herein shall not be modified for on account of increase of Diesel/Petrol/Gas prices or increase in other cost such as maintenance cost, spare parts. There may be revision of transport charges , only in event of change in 'taxes'.

15. DISCIPLINE:

The transport contractor and/or his employees or/any of his authorized representative shall follow proper discipline in the Dairy premises and while dealing with the Distributors/Retailers/Franchise/ of MRSDMM and Co-operate with the staff. The transport contractor or his employees /agents shall not enter into the prohibited area or the laboratory of the Dairy without the permission in writing from Mahasangh/Dairy and shall be responsible for any loss, damage, brokerage, theft or pilferage of milk, milk products and property that is caused by them to the Mahasangh/Dairy. The transport contractor shall be liable to pay to the Mahasangh the amount of loss or damage or shortages caused to the milk products, or MRSDMM property. The transport contractor shall not appoint any other person(s) as his representative for the dealings with the Mahasangh without obtaining the specific permission of the Mahasangh/Dairy in writing.

16. TERMINATION OF CONTRACT:

The Mahasangh is entitled to discontinue the transport contract and/or terminate the agreement and forfeit the security deposit without any notice to the transport contractor on any of the following grounds:

- (a) After delivery of the milk & milk products to transport contractor if the composition, quality or quantity of milk products is found to be adulterated, altered or reformatted from what is supplied by the Mahasangh/Dairy for the delivery.
- (b) If the transport contractor fails to pay the delay charges or compensate losses/damages as provided here in.
- (c) In case of any misbehavior or misconduct or any breach of the rules and regulations or instructions, circulars or notifications of the Mahasangh/Dairy on the part of the transport contractor, or his authorized employee or representative with the staff of Mahasangh/Dairy.
- (d) If in the opinion of the Mahasangh, the transport contractor or his employee, commits any act or deed, injurious to the credit or reputation of the Mahasangh/Dairy or does any act or deeds to

lower down the image of the Mahasangh / Dairy in the eyes of the public or works against the interest of the Mahasangh/Dairy or acts in any of the way in a disgraceful manner or indisciplin manner or causes any harm to the funds and property of the Mahasangh/Dairy.

- (e) If the transport contractor fails to arrange the alternate vehicle to deliver the milk products as per the delivery instructions and/or as per the scheduled time given to him.
- (f) This Agreement may at any time during the duration of this agreement can be terminated by giving one month's notice in writing by the Mahasangh or the transport contractor to other party .On such termination all accounts between the parties shall be settled within 3 months from the date of termination.
- (g) MRSDMM shall be at liberty to recover all losses damages and expenses caused due to commission or omissions of terms and conditions provided herein by the transport contractor. This shall be in additional to the rights of MRSDMM to initiate appropriate legal proceedings.

It shall be the sole responsibility of the contractor to pay all statutory taxes which it is liable to pay.

Force Majeure. Except with respect to payment obligations under this Agreement, no party shall be liable for, nor shall such party be considered in breach of this Agreement due to, any failure to perform its obligations under this Agreement as a result of a cause beyond its control, including any act of God or a public enemy or terrorist, act of any military, civil or regulatory authority, change in any law or regulation, fire, flood, earthquake, storm or other like event, disruption or outage of communications, power or other utility, labor problem, unavailability of supplies, or any other cause, whether similar or dissimilar to any of the foregoing, which could not have been prevented by such party with reasonable care (each, a "Force Majeure Event"). Within 5 days of the occurrence of a Force Majeure Event, the affected party shall notify the other party of the occurrence by sending either (i) an e-mail message, or (ii) a fax message, to the other party. In addition, the affected party shall provide to the other party within seven (7) days of determining the

cause of the Force Majeure Event a written explanation concerning the circumstances that caused the Force Majeure Event. The time for performance required of the affected party shall be extended by the period of such delay provided the party is exercising diligent efforts to overcome the cause of such delay.

17. DISPUTES:

Any disputes arising out of, related with this Agreement shall be subject to the exclusive jurisdiction of courts in Mumbai.

18. STAMP DUTY AND REGISTRATION CHARGES:

The stamp duty and Registration charges if any, in respect of the Agreement/ Award of Contract shall be borne by the Transport Contractor.
